#### Political Party (From any person other than Small Donor):

- **\$ 3,175** ♦ per year no more than \$2,650 ♦ to state party.

#### Political Party (From Small Donor):

- **\$15,900** ♦ per year no more than \$13,250 ♦ to state party.
